11. Posters may only be affixed to street lights in the following streets:	

- 12. A deposit is set by the council (currently R250), from time to time and for a maximum of one hundred (100) posters, to be deposited to Council before any posters are displayed. Said deposit is refundable if -
- 12.1. in the case of paragraph 1 above, all posters are removed (s) to the satisfaction of Council within two (2) days of the event that is displayed on the posters;
- 12.2. In the case of paragraph 2 above, all posters are removed (s) to the satisfaction of the Board is removed within seven (7) days after the expiration of the period mentioned;
- 12.3. Under no circumstances may the ropes / fastening material be dismantled and must properly be removed with ropes / fastening material.
- 12.4. Any damage caused to municipal property due to the installation / removal of the posters;
- 12.5. fully complied with all conditions stated above;
- 12.6. If the number of posters, as indicated on the application form, matches the number of posters actually displayed;
- 12.7. If the Applicant (s) fails to meet any of the above provisions, the Applicant (s) will forfeit the full deposit.
