### **TENDER SPECIFICATIONS**

Non-compliance to specifications will invalidate your offer.

### SCOPE OF WORKS:

This tender is for the supply and installation of fencing for two generators, one situated in Napier and the other in Bredasdorp, Western Cape. The fencing material should be of the Clearview, beta view type. Both installations will require lockable gates that can be locked with a padlock.

All posts to have suitable concrete footings as per manufacturers specification, proof of the design drawings to be submitted with the tender. All fencing material to be galvanized and fixings to be stainless steel. All fencing panels to be 2.4M high with anti-climbing spikes on top of the panels.

### DETAILED SPECS

PANELS

- Minimum 3mm diameter horizontal and 4mm diameter vertical coated core wire
- Maximum aperture of 76mm x 25mm on panels
- 4 Re-enforcing V bends per panel to provide structural strength
- Panels must be 3M wide to be able to accommodate electric fence
- Panels to be minimum 2.4M high with anti-climbing spikes on top

### POSTS

- Same coating as per panels
- Must facilitate that panels are secured behind a lip to prevent panels being levered off.
- Panels must be fixed to the post with stainless steel fasteners of the torque sheer type
- Minimum length 3.0M
- Minimum of 16 fixators per post

### GATES

- Gates to be constructed of the same material as the panels and to be 2.4M wide to accommodate a trailer for filling diesel
- Gates must be of the swing type
- Hinges to be of the security type and fixators to be the torque sheer type
- Gates to be lockable via a concealed locking latch and with a padlock supplied by the Municipality



# **General Conditions of Contract**

### **1. Definitions 1.** The following terms shall be interpreted as indicated:

1.1 "Closing time" means the date and hour specified in the bidding

documents for the receipt of bids.

- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.

1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.

1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.

1.7 "Day" means calendar day.

1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.

1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.

1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.

1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition. 1.14 "GCC" means the General Conditions of Contract.

1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.

1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.

1.17 "Local content" means that portion of the bidding price, which is not included in the imported content provided that local manufacture does take place.

1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.

1.20 "Project site," where applicable, means the place indicated in bidding documents.

1.21 "Purchaser" means the organization purchasing the goods.

1.23 "SCC" means the Special Conditions of Contract.

1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.

1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.

1.26 "Tort" means in breach of contract.

1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.

1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
	5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.


