Cape Agulhas Municipality is currently awaiting tenders for the Supply & Erect of Fencing at The Test Yard of The Traffic Department.

A **compulsory clarification meeting** will be held on **10 February 2022 at 11H00**, at the **Traffic Department, C/o Fabrieks Road & Ou Meule Street, Bredasdorp**. Bidders that fail to attend the compulsory clarification meeting will be disqualified. A representative may only represent one tenderer at this meeting.

Documents will only be available for collection at the compulsory site inspection meeting, and tenderers are required to book their tender documents in advance 2 days before the site inspection. It is estimated that contractors should have a CIDB grading of **1 SQ or higher**

A tender participation fee of R300 is payable for each set of documents issued. Sealed quotations marked "**Quotation Nr: Q21/2021/22 SUPPLY & ERECT OF FENCING AT THE TEST YARD OF THE TRAFFIC DEPARTMENT**" must be placed in the tender box at the municipal offices at No. 1 Dirkie Uys Street, Bredasdorp, 7280 or posted to reach the municipal tender box at PO Box 51, Bredasdorp, 7280 not later than **12:00 on Friday, 04 March 2022** after which it will be opened in public. Tenders may only be submitted on the prescribed official document.

The 80/20 preferential procurement system, as stated in the Cape Agulhas Municipal Procurement Policy, will be used when considering tenders. The **two-stage bidding** process will be followed in evaluating this tender. Firstly, it will be evaluated in terms of the functionality criteria and stipulated minimum threshold for local production and content and thereafter for price and preference point system.

A Tax Compliance status pin as issued by the South African Revenue Service, must be submitted together with the tender.

Council reserves the right not to accept the lowest or any tender. No faxes or e-mails will be accepted.
