The 80/20 preferential procurement system, as stated in the Cape Agulhas Municipal Procurement Policy, will be used when considering tenders. The **two-stage bidding** process will be followed in evaluating this tender. Firstly, it will be evaluated in terms of the stipulated minimum threshold for local production and content and thereafter for price and preference point system.

A Tax Compliance status pin, as issued by the South African Revenue Service, must be submitted together with the tender.

Council reserves the right not to accept the lowest or any tender. No faxes, e-mails or late tenders will be accepted and only the prescribed municipal tender forms, as supplied, may be used.
