Cape Agulhas Municipality is currently awaiting tenders for the repair the offloading area at the Napier and Waenhuiskrans drop off.

Documents will only be available for collection at the compulsory site inspection meeting, and tenderers are required to book their tender documents in advance 2 days before the site inspection. A **compulsory clarification meeting** will be held on **27 June 2022 at 12H00**, at the **Napier Municipal Office, Newmark Street, Napier**. Bidders that fail to attend the compulsory clarification meeting will be disqualified. A representative may only represent one tenderer at this meeting.

A **compulsory clarification meeting** will be held on **27 June 2022 at 14H00**, at the **Arniston / Waenhuiskrans Resort in Arniston**. Bidders that fail to attend the compulsory clarification meeting will be disqualified. A representative may only represent one tenderer at this meeting.

A **tender participation fee of R300 is payable for each set of documents issued**. The fee must be deposited into the account of **Cape Agulhas Municipality** at **Absa**, Branch Code: **632005**, Account Number **405 883 2586**. The reference number for confirmation of payment is: **SCM1 Company Name** and Bid Documents will be made available upon provision of proof of payment.

It is estimated that contractors should have a CIDB grading of **1 CE or higher**.

Sealed quotations marked "**Quotation Nr: SCM1/2022/23 REPAIR THE OFFLOADING AREA AT THE NAPIER AND WAENHUISKRANS DROP OFF**", must be placed in the tender box at the Municipal Offices, 1 Dirkie Uys Street, Bredasdorp or posted to reach the Municipal Manager, Cape Agulhas Municipality, PO Box 51, Bredasdorp, 7280 not later than **12:00 on Friday, 15 July 2022** after which it will be opened in public. Tenders may only be submitted on the prescribed official document.

The 80/20 preferential procurement system, as stated in the Cape Agulhas Municipal Procurement Policy, will be used when considering tenders. The **two-stage bidding** process will be followed in evaluating this tender. Firstly, it will be evaluated in terms of the functionality criteria and stipulated minimum threshold for local production and content and thereafter for price and preference point system.

A Tax Compliance status pin as issued by the South African Revenue Service, must be submitted together with the bid.

The Council reserves the right not to accept the lowest or any tender. No telegraphic, telephonic, telex, facsimile, e-mail and late tenders will be accepted. All late submissions will be returned unopened.
