T1.1 : TENDER NOTICE AND INVITATION TO TENDER

Tenders are awaited for **The Upgrading of the Existing Wastewater Treatment Works Bredasdorp**. The project entails the **UPGRADING OF THE WASTEWATER TREATMENT WORKS IN BREDASDORP** to provide adequate and efficient treatment facilities to treat sewage generated in Bredasdorp and surrounding areas. The proposal includes the construction of a new inlet works, new raw sewage pump station, lining of over-flow pond, a new 3.6 M³/d ADWF biological reactor, a new 17 m diameter secondary settling tank, a new chlorine contact channel, minor building works and all related pipe work.

Documents will be available for collection at the compulsory site inspection meeting if tenderers booked their tender documents in advance 2 days before the site inspection. A non-refundable fee of **R250.00** is payable for a set of documents. The fee must be deposited into the account of **Cape Agulhas Municipality at Absa**, Branch Code: **632005**, Account Number **405 883 2586**. The reference number for confirmation of payment is: **SCM13 Company Name** and Bid Documents will be made available upon provision of proof of payment.

It is estimated that contractors should have a CIDB grading of **7CE or higher**.

A compulsory clarification meeting will be held only on **Wednesday, 28 August 2019 at 11h30**, where tenderers will meet at the **Committee Room at Old Nedbank Building, Van Riebeeck Street, Bredasdorp**, for a brief discussion on the tender, procedures and scope of works after which all tenderers will be accompanied to the Bredasdorp WWTW for a site inspection. **Non-attendance of the compulsory briefing session will disqualify your tender.** Bredasdorp WWTW Co-ordinates: **33° 49' 06" S 19° 52' 26" E**

Completed tenders in a sealed envelope marked "**Tender for Contract SCM13-2019-20: The Upgrading of the Existing Wastewater Treatment Works Bredasdorp**" must be placed in the tender box at the municipal offices at No. 1 Dirkie Uys Street, Bredasdorp, 7280 or posted to reach the municipal tender box at PO Box 51, Bredasdorp, 7280 before **12h00 on Friday, 20 September 2019** where after the tenders will be opened.

Only tenderers who meet the pre-qualification criteria by sub-contracting a minimum of 30% of the contract value to an EME or QSE as stipulated in paragraph 4(1)(c) of the PPPFA regulations of 2017 will be eligible for further evaluation. A tender that fails to meet any pre-qualifying criteria stipulated in the tender documents will be regarded as non-responsive.

The **two stage bidding** process will be followed in evaluating this tender. Firstly it will be evaluated in terms of the stipulated minimum threshold for local production and content and thereafter for price and preference point system. The 80/20 preferential procurement system, as stated in the Cape Agulhas Municipal Procurement Policy, will be used when considering tenders.

A Tax Compliance status pin or a printed Tax Clearance certificate, as issued by the South African Revenue Service, must be submitted together with the bid.

The Council reserves the right not to accept the lowest or any tender. No telegraphic, telephonic, telex, facsimile, e-mail and late tenders will be accepted. All late submissions will be returned unopened.
