Cape Agulhas Municipality is currently awaiting tenders for the Maintenance Contract of Mechanical and Electrical Equipment for Water and Sanitation Infrastructure at Cape Agulhas Municipality for Period Ending 30 October 2025.

A **compulsory clarification meeting** will be held on **26 September 2022 at 11H00**, at the **Council Chambers in Audrey Blignault Street, Bredasdorp**. Bidders that fail to attend the compulsory clarification meeting will be disqualified. A representative may only represent one tenderer at this meeting

Documents will be available for collection if tenderers booked their tender documents in advance 2 days before the site inspection. It is estimated that contractors should have a CIDB grading of **4 ME or higher**.

Tenders may only be submitted on the prescribed official document.

The **two-stage bidding** process will be followed in evaluating this tender. Firstly, it will be evaluated in terms of the functionality criteria and stipulated minimum threshold for local production and content and thereafter for price and preference point system. The 80/20 preferential procurement system, as stated in the Cape Agulhas Municipal Procurement Policy, will be used when considering tenders.

A Tax Compliance status pin as issued by the South African Revenue Service, must be submitted together with the bid.
