TERMS OF REFERENCE/ SCOPE OF WORKS

1. Introduction

Cape Agulhas Municipality requires the services of an accredited service provider for the supply, replace and service of fire extinguishers, as prescribed in terms of the Occupational Health and Safety Act, Act 85 of 1993 and Regulation.

2. Background

The municipality's buildings are occupied by staff members and daily visitors who are clients or members of the public. Municipal buildings are equipped with confidential documentation and ICT equipment. In the event of a fire, lives, equipment and documentation can be secured by the use of first aid firefighting equipment.

The need for First Aid Fire Fighting Equipment derives from the Occupational Health and Safety Act and the National Building Regulations, SANS 10400. First Aid firefighting equipment forms part of the Emergency Evacuation Plan of the municipality

3. Scope

In terms of the Occupational Health and Safety Act, Section 9 of the Environmental Regulation for Workplaces, every employer must provide on its premises where flammable articles are used, an adequate supply of suitable firefighting equipment at strategic locations. Such equipment shall be maintained in good working conditions.

Therefore, the following services are required:

- 3.1. To service and maintain portable firefighting equipment for Cape Agulhas Municipality on an annual basis.
- 3.2. Maintenance and service of fire extinguishers in accordance with SANS 10105-1.

4. General

- 4.1 The contract period will commence upon the date of signing the contract.
- 4.2 Validity period of tender will be 90 days after the closing date of this tender.
- 4.3 The bidder must be registered with the Compensation Commissioner in terms of COIDA Legislation.
- 4.4 Servicing of firefighting equipment will be done on-site.
- 4.5 The successful/ appointed service provider will prior to servicing or replacing any fire protection equipment, inspect the condition and the quantity thereof in conjunction with a representative from the Human Resources Department (Occupational Health and Safety Section).
- 4.6 The tenderer must provide all the tools required for the proper execution of the work at his/her own expense.
- 4.7 For asset control purposes all redundant material(s) and equipment will remain the property of the municipality unless otherwise stated.
- 4.8 The municipality will not allow the tenderer to sub-contract any of the services.
- 4.9 All travelling and labour cost must be included in all prices.

5. Technical Requirements:

5.1 FIRE EXTINGUISHERS

Maintenance and Servicing

- 5.1.1 If fire extinguishers have to be removed from site, the necessary arrangements are to be made with the representative from the Human Resources Department (Occupational Health and Safety Section) to ensure satisfactory protection with a replacement.
 - This must be done in accordance with Sec 4.6 of SANS 1475-1:2010

5.1.2 Filling Mediums

- 5.1.2.1 Only powder that complies with the requirements of SABS 1522 shall be used for refilling fire extinguishers.
- 5.1.2.2 If, during servicing, powder is removed for the effective inspection and control of a cylinder, the powder may
 - be re-used, subject to:
 - a) The powder shall be sieved and if it is determined, during sieving, that the powder is free from lumps, the powder may be re-used; if not, it shall be discarded.
 - b) Powder so qualified for re-use shall be identified with the cylinder from which it was removed.
- 5.1.2.3 C0₂ extinguishers shall be charged with C0₂ that complies with the requirements of SABS 1567.
- 51.2.4 Foam extinguishers shall be charged only with the type of foam marked on the extinguisher label.
- 5.1.2.5 C0₂ and foam extinguishers shall not be topped up but shall be emptied and fully recharged.
- 5.1.2.6 Major servicing of all type of extinguishers as lay down in SABS global conformity services (PTY) Ltd 0600 Section 7737 and global conformity services 0105 and company code appertaining to each type of extinguishers.

5.1.3 External checks

- 5.1.3.1 Thoroughly clean the container and examine the exterior for corrosion and physical damage. If any damage to the seams or joints is observed, remove the extinguisher from service and submit it for a major service.
- 5.1.3.2 If there are minor dents in the container, remote from any seam or joint, allow the extinguisher to remain in service.
- 5.1.3.3 If the registered person does not consider the severity and extent of corrosion to be serious; clean, repaint and re-label the container in a way that ensures compliance with the requirements of the original manufacturer.
- 5.1.3.4 Check all components for corrosion and physical damage (i.e. breakage, deformation, cracks, discolouration of plastic parts, etc.). If necessary, replace parts with the correct components recommended and supplied by the fire extinguisher manufacturer. If such components are not available, use parts that comply with the requirements of the original manufacturer. If this is not possible, the extinguisher shall be condemned and replaced with a new one.
- 5.1.3.5 Verify that the pressure indicating device is operative.

5.2 FIRE EXTINGUISHER HOSE REQUIREMENTS

- 5.2.1 Examine it for wear and kinking.
- 5.2.2 If the fire hose is not in good condition, replace it with a fire hose of acceptable quality and design.
- 5.2.3 Examine the mounting brackets for physical damage and firm anchorage.

5.2.4 Mass of extinguisher

- 5.2.4.1 Determine the full mass of the extinguisher and, if it is found to vary by more than 5% from the marked full mass, present the extinguisher for a major service.
- 5.2.4.2 If no mass is marked on the extinguisher, determine the actual mass and record it on the new service label attached to the extinguisher.

5.2.5 Service labels

- 5.2.5.1 When all the relevant inspection and service procedures have been completed, record, indelibly and on an acceptable, waterproof, adhesive label that is firmly fixed to the fire hose reel, the following information:
- 5.2.5.1.1 the name, physical address and contact number of the reconditioning organization
- 5.2.5.1.2 the date of service; and
- 5.2.5.1.3 the next service due date;
- 5.2.5.1.4 pressure at time of service;
- 5.2.5.1.5 the handle shall be sealed in a manner that prevents use without breaking using an acceptable safety seal.

- 8.1.1 Tender price per unit must include standard service spares safety pin, safety seal, valve assembly 'O'ring seal, hanging bracket replacement (if required), sifting of powder, and weighing of content, Nitrogen gas recharge and travelling cost.
- 8.1.2 Inspection and maintenance must be in strict accordance with SANS 1475-1:2010 Edition 3.4 Annex C -Procedures for Maintenance and Annex D - Extended Maintenance Procedures and SANS 10105-1 Use and Control of Fire Fighting Equipment – Portable and Wheeled (Mobile) Fire Extinguishers.

8.2 PRICE FOR REPLACEMENT OF UNSERVICEABLE FIRE EXTINGUISHERS (NEW)

8.2.1 Tender price per unit must include supply of hanging bracket, back plate, installation where required and cost on all standard labour and travel. Replacement of equipment will only be approved after the condemned item has been returned to the Municipality for evaluation by the controlling official.

- Bid prices must include all expenses, disbursements, and costs (e.g. transport, accommodation etc..) which may be required for the execution of the bidder's obligations in terms of the contract.
- Where the value of an intended contract will exceed R1 ,000 ,000.00 (R1 million) it is the bidder's responsibility to be registered with the South African Revenue Services (SARS) for VAT purposes in order to be able to issue tax invoices. The municipality will deem the price above R 1 000 000,00 (R1 million) to be VAT inclusive even if it indicated that no VAT is charged. - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.

1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.

1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.

1.7 "Day" means calendar day.

1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.

1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.

1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.

1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.

1.14 "GCC" means the General Conditions of Contract.

	5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
	5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

	15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.
16. Payment	16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
	16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.16.4 Payment will be made in Rand unless otherwise stipulated.
17. Prices	17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

18. Variation Orders	18.1 In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such.
