T1.1 Tender Notice and Invitation to Tender

The **CAPE AGULHAS MUNICIPALITY**, invites tenders for Tender No. **SCM24-2023-24: Construction of A Solid Waste Drop Off Facility and Associated Civil Works at Bredasdorp**

Documents will only be available for collection at the compulsory Clarification Meeting. Tenderers must pay and book their tender documents in advance, 2 days before the site inspection. It is estimated that tenderers should have a CIDB contractor grading designation of **4CE** or higher.

A tender participation fee of R300 is payable for each set of documents issued. The fee must be deposited into the account of **Cape Agulhas Municipality** at **Absa**, Branch Code: **632005**, Account Number **405 883 2586**. The reference number for confirmation of payment is: **SCM24 Company Name** and Bid Documents will be made available upon provision of proof of payment.

A compulsory clarification meeting will be held on **29 November 2023 at 11H00**, at the **Bredasdorp Materials Recovery Park, old P&B Lime Works**. Bidders that fail to attend the compulsory clarification meeting will be disqualified. A representative may only represent one tenderer at this meeting.

Sealed tender marked "**Tender Nr: SCM24/2023/24 CONSTRUCTION OF A SOLID WASTE DROP OFF FACILITY AND ASSOCIATED CIVIL WORKS AT BREDASDORP**", must be placed in the tender box at the Municipal Offices, 1 Dirkie Uys Street, Bredasdorp or posted to reach the Municipal Manager, Cape Agulhas Municipality, PO Box 51, Bredasdorp, 7280 not later than **12:00 on Wednesday, 20 December 2023** after which it will be opened in public. Tenders may only be submitted on the prescribed official document.

The 80/20 preferential procurement system, as stated in the Cape Agulhas Municipal Procurement Policy, will be used when considering tenders. The **two-stage bidding** process will be followed in evaluating this tender. Firstly, it will be evaluated in terms of the functionality criteria and stipulated minimum threshold for local production and content and thereafter for price and preference point system.

Responsive tenders that meet the minimum responsiveness criteria will be evaluated in terms of the CIDB evaluation method, Method 2, using the 80/20 points system. The Preferential Procurement Regulations, 2022 will be used for the determination of Preference Points claimed.

A Tax Compliance status pin as issued by the South African Revenue Service, must be submitted together with the bid.

The Council reserves the right not to accept the lowest or any tender. No telegraphic, telephonic, telex, facsimile, e-mail and late tenders will be accepted. All late submissions will be returned unopened.
