### **T1.1 Tender Notice and Invitation to Tender**

Bids are invited by the Municipal Manager of **SCM27-2018-19: THE CONSTRUCTION OF WATER, SEWER AND ROADS SERVICES FOR 22 LIGHT INDUSTRIAL ERVEN IN STRUISBAAI**. **The scope of works consists of the construction and servicing of 22 industrial erven in Struisbaai.**

It is estimated that the Tenderers for the main contract should have a CIDB contractor grading designation of **5CE** or **4CE PE** and a prerequisite of **65%** exist for Functionality.
