Whereas:



- (a) CAM and ASLA entered into a Memorandum of Understanding signed on 21 June 2013 in terms of tender SCM 29/2012/13;
- (b) CAM has taken certain decisions regarding housing delivery and pockets of land with specific reference to Area "H", as per annexure F to the original MOU;
- (c) Clause 4.1 of the MOU allows for the inclusion of additional land parcels identified and approved by CAM during the effective period of the Agreement;

Therefor the parties agree:

That Area "H" be included into the scope of the MOU insofar as it relates to the provision of internal services for the purposes of providing houses in terms of the People's Housing Project programme of the DOHS. Payment for the works will be a combination of subsidy funds, as may still be available for the project, as well as Municipal funds.
