THEREFORE the PARTIES record their acceptance of this Addendum to the AGREEMENT as follows:


The Parties accept and confirm that:


1. The MOA articulated the scope of the appointment in paragraph 2 as well as within Annexure F to the MOA. In terms of the contractually agreed scope, based on the Municipal Human Settlement Plan 2012-2017, as well as the progress to date; the following projects remains part of the scope:
 - a. Bredasdorp Site D2
 - b. Napier Site B
 - c. Struisbaai Site A
 - d. Bredasdorp Site F
 - e. Napier Site A1 & A2
 - f. Bredasdorp Area H – provision of services
2. Paragraph 3 pertains to the commencement date and period of implementation. The effective period of implementation is herewith extended for a further two years. As this extension is provided for in the MOA it does not constitute an amendment of the contract.
3. All relevant conditions and requirements of the tender and duties and obligations as contained in the particular contracts will remain applicable.





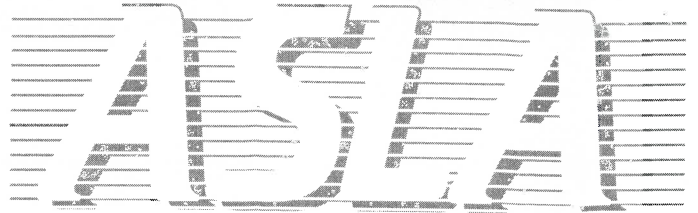
