TECHNICAL SPECIFICATION

1. AUTOMATIC REAL TIME NUMBER PLATE RECOGNITION SERVICE

Formal tenders are invited for the connection of existing and possible new license plate recognition (LPR) cameras located in the Cape Agulhas Municipal area, that includes all 9 Towns in the Municipal area to an automatic license plate recognition system, internet connections already established, access to national license plate database and alert monitoring, as follows:

Existing sites 28 Sites

Bredasdorp 9 x LPR cameras Stormsvlei turnoff – Bredasdorp, Napier Road R316/R317 Turnoff 2 x LPR cameras Napier 4 x LPR cameras Napier / Klipdale Turnoff 2 x LPR cameras Klipdale 2 x LPR cameras Protem 2 x LPR cameras Elim 5 x LPR cameras Arniston 2 x LPR camera

Possible future sites

To be determined. Although no immediate sites are currently identified, we made provision in the pricing schedule for possible future expansion of the LPR network.

The prospective Service Provider should understand that the likelihood of these sites to grow exponentially is low as other implementation cost factors also need to be considered.

We did however make provision for additional cameras in the pricing schedule should the need become more prudent. The service provider should take note that these quantities is only for evaluation purposes and may possible not realise beyond the 28 cameras over the term ending November 2024.

The tenderer must tender for all items to be deemed responsive.

Per unit pricing as tendered shall remain valid for extension of the contract to accommodate monitoring of additional cameras if required.

Billing will be monthly after services rendered for all active cameras.

The tender shall include the following

- Installation of the monitoring firmware for the cameras
- All programming and setup of the existing Hikvision LPR cameras and shall link into the custom Hikvision firmware. If required, the installation must be done by a trained/certified installer. Proof of certification must be attached to the tender
- The firmware must be compatible with the existing Hikvision LPR cameras currently used. The following Hikvision LPR cameras are in operation:
 - Hikvision DS-2CD7A26G0/P-IZS
- Alignment to be done by the existing service provider of the Municipality with the assistance of the bidder.
- Upgrading of the Hikvision camera firmware to be compatible with firmware being loaded, if required
- The system shall be capable to identify license plate numbers of moving vehicles up to 100 km/h from IP Video at 99.9% accuracy.
- The system must be cloud based in which case all data must be stored in South Africa.

Upon identification of a suspect number plate, alerts including the image of the suspect vehicle shall be sent directly to all approved users of a WhatsApp- or Telegram groups as well as to email addresses to be provided. The application used for notifications must make provision for encryption of information in transit.

Online access to the database log of all vehicles recorded by the LPR cameras shall be available for at least 2 months including location, date, time, image, license plate number and suspect reports where applicable by means of a web interface or other applications.

Online access is required by law enforcement officers to search the complete database against any license plate number entered into the system and to enter details of new suspect vehicles.

The system must have the ability to create a proprietary database for municipal use and purposes and searches against that database or notifications set against that database must be available as a full functionality of the system.

There must be no limitation in access for users as may be identified from time to time by the Municipality.

The bidder needs to ensure and provide proof that the system and service provider is POPIA compliant.

The objective is to connect all the existing sites of Cape Agulhas Municipality within One (1) month (dependent on budget availability) of the signing of the contract. Possible future sites of they may be required also as will be identified from time to time.

The Municipality will always be the owner of all data as defined during the SLA discussion process.




Figure 1: CAM War

- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.

1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.

1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.

1.7 "Day" means calendar day.

1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.

1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
