Addition to Schedule 3 of the Cape Agulhas Municipality Liquor Trading Hours By-Laws 14 December 2012:

Schedule 3(7) to be added:

That all liquor traders selling alcoholic beverages may sell liquor on Sundays from 9:00 tot 18:00.
