L'AGULHAS LIFESTYLE ESTATE: WATER USE AUTHORISATION

Your letter dated 26 August 2019, regarding the above-mentioned has reference.

After consultation with the head of department and middle managers responsible for water and sanitation at the Cape Agulhas Municipality (Messrs Abdul Aziz Jacobs, Deon Wasserman and Shane Roach) on 27 August 2019, it is hereby accepted that:

- (a) The proposed development will generate a gross average daily water demand of approximately 314 m³/day or 114 610 m³/annum.
- (b) The combined sustainable yield from KOOS2 and AGULH04/A is estimated at 520 m³/day or 189 800 m³/annum.
- (c) The water from the on-site boreholes (KOOS2 and AGUL04/A) is therefor sufficient to supply the development with its required potable water needs and to supplement requirements elsewhere.
- (d) The most suitable solution for the supply of water to the development by the municipality would be to pump the water from the on-site boreholes as a supplementary water source to the municipal reservoir.
- (e) Treatment, distribution and metering would still be the responsibility of the municipality.

This acceptance is supported by the findings in the "L'Agulhas Links Golf Estate Assessment of Groundwater Resources for Water Supply and Environmental Impacts – November 2004" report compiled by SRK Consulting and the assumption that the mentioned boreholes were, and are not currently, in use.

Any correspondence regarding the future transfer of the boreholes to the municipality in support of the current L'Agulhas Lifestyle Estate development may be directed to the writer.
